**Office Memorandum**

**Subject: Draft Integrated All India Seniority List of Administrative Officers of Customs for the period 01.01.2019 to 31.12.2020 – regarding**

The Central Board of Indirect Taxes & Customs has entrusted DGHRD to prepare Integrated All India Seniority Lists (AISL) of Administrative Officers of Customs. Accordingly, this Directorate has prepared the draft AISL of Administrative Officers of Customs for the period from 01.01.2019 to 31.12.2020 which is attached as Annexure-A. The said draft AISL has been integrated on the basis of Zonal Seniority Lists received from the respective Cadre Controlling Authorities attached at Annexure-B. While integrating the draft All India Seniority Lists, the following principles have been kept in view:

- i. DOP&T's instructions on Seniority and Promotion;
- ii. Date of Regular Appointment in the grade of Administrative Officers;
- iii. Relative Seniority of Administrative Officers in their respective Zone to remain same in All India Seniority List;
- iv. All India Seniority amongst the officers promoted on same date to the grade of Administrative Officers to be determined with reference to their length of regular service in the feeder grade;
- v. If the date of promotion to the grade of Administrative Officers as well as date of regular appointment in the feeder grade is same, the officers having earlier dates of birth to rank higher than those with later dates of birth.

**2.0** The concerned Cadre Controlling Authorities are requested to circulate this draft Integrated All India Seniority List of Administrative Officers of Customs amongst all concerned officers and invite objections, if any. The same is also being uploaded on the DGHRD & CBIC website. DGHRD is mandated only to integrate the Zonal Seniority List received from respective CCA's and is not empowered to decide on the Seniority of the Officer in the Zone and therefore no correction/alterations can be initiated till it is decided at the Zonal Level by the CCA's. The Cadre Controlling Authorities may, after examination of the objections received at the Zonal Level, forward the same along with

their **comments** to this office via email to sl.dghrd@gov.in. It may kindly be noted that in case no response from the Cadre Controlling Authorities is received **within 15 days** of its publication on [www.dghrdcbic.gov.in](http://www.dghrdcbic.gov.in) & [www.cbic.gov.in](http://www.cbic.gov.in), the draft seniority list shall be deemed to be final.

3.0 No direct representation from the officers to this office shall be entertained.
